Speaker bios



Tom Guthrie is a statewide equine extension educator for MSU. Tom is based in the MSU Extension office in Jackson County. His role for MSUE is to develop and provide statewide accessibility to educational programming in regard to equine management, including horse farm environmental management. Tom has Bachelor's degrees in Animal Science and Forestry and a Master's degree in Animal Science with a nutrition emphasis.



Debby MacDonald is the chief investigator and Detroit shelter director for MHS. She has been with MHS for 24 years and has been a cruelty investigator for 20 years. Deborah is qualified as an expert witness in dogfighting investigations. She is currently an instructor for Code 3 Associates/Colorado State's Cruelty Investigations Academy and has taught throughout the U.S.



Terry MacKillop is current and past president, and legislative liaison of MAACO. He also is the director and chief administrator of the Roscommon County Animal Control and Shelter. Terry has a criminal justice background and over 23 years of animal control and sheltering experience. He represents animal control in several state-level groups, including the Michigan Department Agriculture Rural Development small companion animal committee and the Michigan State Animal Rescue Team. Terry is president of Wolfe Pack, a nonprofit organization that educates lawyers and rescue groups on animal cruelty laws and humane welfare guidelines and how to work with local animal control. He also operates TLM Consulting which brings local municipalities under state compliance and helps them to achieve the highest standards in the animal

control and sheltering. Terry was voted Animal Control Employee of the year in 2007 by the National Animal Control Association. His true passion is to see animal welfare grow as the need grows in the state of Michigan.



Linda Reider is the Director of Statewide Initiatives for the Michigan Humane Society. She works closely with animal welfare professionals in Michigan to ensure that up-to-date training and networking opportunities are provided through the Michigan Partnership for Animal Welfare (MPAW). Linda has 28 years of experience in the animal welfare field.



Karen Waite is an equine extension specialist in Michigan and teaches and advises equine students in the MSU Department of Animal Science. In her extension roles she coordinates the Adult Equine Extension program, the Michigan Equine Survey, and is the director of leadership development for My Horse University. In addition, she oversees the Youth Equine Extension program and is active with eXtension Horse Quest. Her teaching responsibilities include a variety of equine courses, coaching the MSU Horse Judging Team, and faculty advisor to the MSU Equestrian team and Horsemen's Association. Karen also oversees the Michigan 4-H PEP Program for riders with disabilities. Karen is the President of the American Youth Horse Council, Vice President of the Michigan Quarter Horse Associat ion and is a carded judge with the

ABRA and POAC. With Bachelor's Degrees in Education and Animal Science, and a Master's Degree in Animal Science with a nutrition emphasis, Karen is presently working on a Doctoral degree in Sports Psychology with an emphasis on equestrian sport and activity.
